

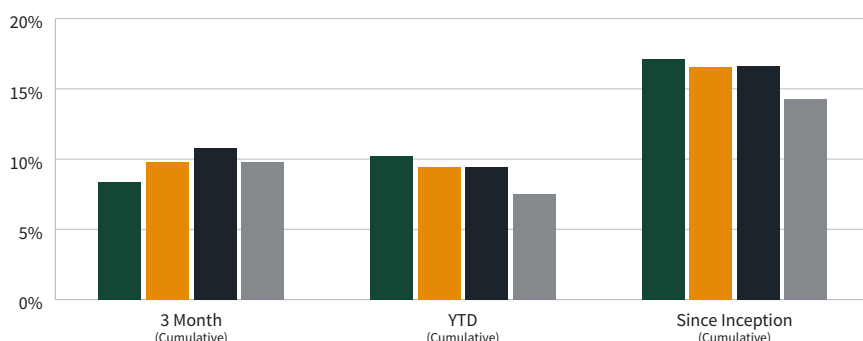

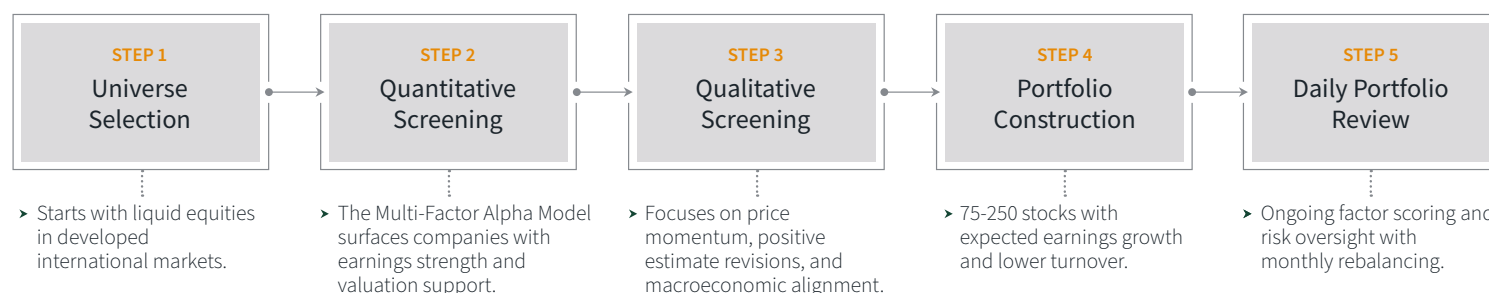

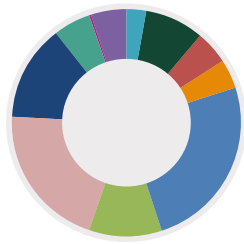
Investment Process Summary

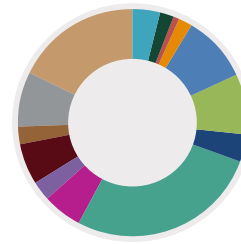
